In order to maintain the high level of quality and service that the Users' Club offers, we would be obliged if you would take note of the following rules and regulations of the Club.

- 1. The Users' Club is an English language only organization. All correspondance between members of the club and the Club must be in English.
- 2. The Users' Club exists to offer a library of programs that have been written by fellow 67/97 users. In order to maintain the quality both physical and technical the following guidelines must be adhered to when submitting programs.
- All submittals must be on original submittal forms.
- All submittals must be in English.
- Submittals must be hand written in black ink or typed.
- No special symbols must appear in the "Abstracts" section.
- In the case of HP-97 programs, it is preferred to have the actual program listing attached.
- Where possible the program should be recorded on a magnetic card(s) and attached to the Submittal form. (This card will be returned to the user.)

Upon acceptance

When a program is accepted, the writer will be sent either, 2 programs chosen by him from the library or 1 program and 10 blank magnetic cards in appreciation of his work.

The Club's staff reviews all submittals, checking for duplicate entries, duplication of existing programs from HP Application Pacs, clear and complete documentation in English, legibility, and ability to perform sample problem(s). Inasmuch as your fellow HP-67/97 owners expect a significant program for their money, we reserve the right to reject programs which do not represent a significant addition to other users. If a program is not accepted, the complete submittal package is returned with a letter of explanation. If accepted, we notify you by letter and give you the assigned program number. At this time, you will also receive the complimentary option you have selected.

- 3. Programs from the library should be ordered under the following conditions:
 - All orders must be on the official order form.
 - Minimum acceptable order is 4 programs.
 - All orders for less than 10 programs <u>must</u> be accompagnied by payment by cheque for the relevant amount.

- French and Spanish residents are not allowed, due to currency regulations, to pay by cheque. They will be invoiced automatically and must then pay by bank transfer.

These conditions will make life easier for all of us and will greatly increase the efficiency of the club.
